Bonjour tout le monde,

While the term of the Agreement (i.e., 1 July 2023 to 20 June 2026) is a valid concern for us, what is of greater concern is the Employer's stalling to confirm our tentative agreement and to address the three missing agreed-upon articles, two of which are on the RTPP process. I continue to work with CAUT and with our union lawyer to get them moving and will continue to keep you posted whenever I have further information.

Kelly and I are nevertheless proceeding with the revamping of the online RTPP workshop given that we are now well into July. Significant changes were made to the articles related to RTPP and so the workshop must be completely redeveloped, which is time-consuming. Our first task is to provide you with the draft of the tentative agreement language for you to use in preparing your application for Reappointment, Tenure/Permanence, and Promotion (see attached). As indicated in the header of the articles, some of them are pending since we are still awaiting confirmation by the Employer since mid-April. At some point, the Employer will have to sign our Agreement and the files will have to be assessed; so, the sooner you start preparing, the better. For this reason, I am hurrying to get you these drafts and will provide an executive summary of the changes as part of the workshop. This workshop is to be jointly developed and maintained with the Employer. However, consistent with the Employer's comportment in labour relations thus far, it is not surprising that it is again up to us to do the work. I Once we have the RTPP workshop up and running, we will provide you with the link to it. In the meantime, please review the articles as they pertain to your situation, and as always, we welcome your questions.

Note that your bargaining team is continuing to work on concluding the negotiations despite the Employer paying a lawyer and senior admin to do so. We are just as frustrated as you are, if not more, since this is continuing to obstruct our work, even while some of us are on sabbatical. I ask that you please appreciate we are doing this as a service to our collective and that all we ask is for you to support your Exec and your bargaining team through this.

Hi all. 1.

Confirmation that the union will not be signing off on the date mentioned in one of the updates of March 2024 as the start date for the new CA. The start date should be July 1, 2023 because if the backpay, pension pay, and benefits are effective only as of March 2024 all members will lose a significant entitlement that has always been backdated to the expiry of the last CA.

2.

Update on how long it is estimated it is going to take to get to the point of the CA being signed and our back pay (including pension monies) and any overloads from summer 1 2024 expected.

I know this has been an onerous process and if you cannot answer number 2 can you at least assure that we will not be agreeing to the March 2024 date for the start of the new CA?
